Scores are applied by hole to each partnership - 1 point per win, ½ point per tie, 0 point per loss. Then each partnership's scores will be added within the two teams to determine a winner. Players are encouraged to dress as "Angel" or "Fire". Scores are net of your course handicap.

Handicap Chairman Jamie Elliott reminds the membership to post scores after each play and to post hole by hole.

Vice President Sharon Johnson provided an update on the AFLGA Championship Tournament.
