Treasurer Report - Noel (See Treasurer's Report for full details) Balance to date = \$2,644.73 Designated funds (Year 2023) = \$2,385 including \$500 Charity Check for Youth Golf. Working available balance = \$779.73

Handicap Chairman - Robin Robin will take over HCP position. All questions regarding HCP will now be directed to Robin.

New Member Liaison - Ginny Discussion regarding new member Welcome bags. Board members are encouraged to pick up small items to donate for new members.

Board motion to allot \$100 to New Member Liaison to purchase items for New Member bags. Motion by Diana, Second by Amy; motion carried.

Old Business - Guys and Girls Tournament, Couples Events Discussion was held to change the name from Guys and “Dolls” to Guys and Girls Tournament. (This event was not held during the 2022 year.) Couples Golf could work but not as a 9-Hole event late in the day. If LGA wants to proceed, Couples Golf day would need to be 18 Hole with shotgun start and scheduled in the mornings. Diana will check the schedule for dates in late June or the end of August if the Board wishes to proceed.
