

AFLGA Board Meeting Minutes Tuesday, August 22, 2023 Angel Fire Resort

Call to Order President Mandy Hollemann called the meeting to order at 1:33 pm MST.

Approval of Board Meeting Minutes - August 1, 2023 Motion to approve by Amy; 2nd by Diana; motion approved.

Treasurer Report -Treasurer Noel reports approx. \$919.00 from the Ladies Championship balance. Last play day, Putt Me In, has not yet been deducted. **Final financial report was not yet available at the time of this meeting.* Short discussion regarding surplus monies to be allocated for LGA to purchase their own sponsorship signs for future events. Renida will investigate and look for best prices online.

Play Day Chair - Diana reports strong attendance for all games. Next week's game, Par 4s, was announced. A discussion regarding Golf Genius (GG) was held. Since the resort has already purchased this app, LGA members will be asked to download the app and be prepared to use it for the 9/5 play day. The motion to use GG for all games will be presented at the next general meeting 8/29.

Rules Chair - Sherrie received feedback from members that having the rules reviewed before the championship was helpful.* A discussion was held regarding rule violations during the championship. Protocols for future violations will be: 1st offense: Verbal discussion between Rules Chairperson, President, and player; 2nd offense: verbal discussion between Rules Chairperson, President, player, and formal documentation; 3rd offense: verbal discussion between Rules Chairperson, President, player, formal documentation (in writing), and the player will be disqualified from LGA games. This matter will be addressed at the next general meeting (8/29).

Handicap Chair - Robin will check to ensure ladies entered the Championship dates as "C" for competition. Discussion was held that all ladies play days are considered "competition" and should be regarded as such when entering scores into Sun Country. *The only exception to this is during LGA Scramble events. Once ladies have access to Golf Genius, they will enter all scores hole-by-hole.

New Member Liaison - Ginny reports that new members have received rules cards and personal counters to track strokes. Once ladies are using the GG app, they will enter all strokes upon completion of each hole.

Old Business - Pendaries beneficiary for 2023 Silent Auction. We are still working to find a contact person at Pendaries. The silent auction is still in progress with the proceeds to be split between MVHS Wolfpack Team and Pendaries General Rebuilding Fund.
